Land taken for the Purposes of a Recreation-ground and for Forest-plantation Purposes in Block XVI, Belmont Survey District.

A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken, under the Public Works Act, 1908, for certain public works—to wit, for the purposes of a recreation-ground and for forest-plantation purposes in Block XVI, Belmont Survey District:

And whereas an agreement has been entered into between the Mayor, Councillors, and Citizens of the City of Wellington and the owner of the land described in the Schedule hereto, to take such land for the public works hereinafter set forth:

And whereas the Wellington City Council has laid before the Governor-General a memorial, accompanied by a map in duplicate, as required by the Public Works Act, 1908:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, the Public Works Amendment Act, 1910, and the Municipal Corporations Act, 1908, and of every other power and authority in anywise enabling me in this behalf, and being satisfied of the sufficiency of the agreement hereinbefore referred to, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of a recreation-ground and forest-plantation purposes as aforesaid, and shall vest in the Mayor, Councillors, and Citizens of the City of Wellington, on and after the date hereinafter mentioned; and I also hereby declare that this Proclamation shall take effect on and after the first day of May, one thousand nine hundred and eighteen.
