Hi Blair. May I please have the latest slide show which I will share with Tui. She is OK to lead the Karakia and say some preliminary words, for which I will provide her with some bullet points.

You and Jeremy comfortable with the following points.

- We absolutely recognise and acknowledge the offensive nature of the odour emanating from the plant and its effect on local residents and businesses.
- We sincerely apologise and undertake to do what we practically can to address the issue both in the short and medium term.
- The work that is being undertaken now to replace the biofilter will help reduce the level of offensive odour but will not eliminate it.
- Council is currently considering significant investment over the next 3 years in the plant through the Long-Term Plan, which will contribute to significantly improving the odour situation.

Please let me know your comments. We'll continue to finetune but won't make any significant changes until we receive your feedback.




### Kia ora,

We discussed the pushing back Eastern Hills yesterday in a workshop with us.

There are risks (which Laurence can describe) but on balance the consensus was that Seaview dryer in particular was higher priority. Opex costs and landfill implications were part of that. We discussed potentially bringing it ahead of Petone Collecting Sewer stage 2 depending on how condition inspection information and other information played out over the next 3 years, but that can follow for next LTP.

### Morena Laurence and Steve

I am currently preparing information and comment for Council for the LTP. Just wanted you two gents to run your eye over these comments following a meeting with Adrienne and Paul yesterday to go over some of the CAPEX investment options.

1. WWL and its wastewater treatment plant operator Veolia, have recently completed a comprehensive review of the operating plant at the Seaview site. This has revealed that investment is required as a matter of priority for some critical plant items. Consequently, and to manage borrowing limitations, it is proposed to push out the commencement of the construction of the new Eastern Hills Reservoir for a few years until 20xx. This has some risk as water storage does not currently comply with minimum back-up storage standards and additional growth on the valley floor over the next 5 years will exacerbate that situation. However, the consequences of not investing in the renewal of existing plant at Seaview has greater risk, with plant failure resulting in breaches to resource consents and/or sludge not being able to be dried.

Hi Bruce,

As discussed, WWL have not received any complaints directly but we have been notified of a number received by GWRC since work on the biofilter was halted 22 December. At that time, all 6 cells of the biofilter had new media added and the system was fully operational. As we have indicated, the new media takes some time to "bed in" and become fully functional.

Odour complaints (6) that I am aware of as follows:

- 27 Dec 23 1 complaint no address given, but residential 17.55hrs No assessment undertaken by GWRC
- 28 Dec 23 2 complaints (Leighton Avenue and Bell Road) 14.04hrs and 12.21hrs. GWRC attended site at 15.13hrs and completed an odour assessment at Seaview Roundabout. Detected odour but not O&O.
- 1 Jan 24 3 odour complaints (addresses unknown at this stage) GWRC undertook odour assessments at Bell Road (13.57hrs) no odour detected and at Seaview Roundabout (14.05hrs) odour detected but not O&O.

These are the complaints that GW have informed us of.

As far as we are aware the biofilter is operating as expected and other areas of potential odour from maintenance issues are being carefully managed.

Hi Bruce,

The main projects that targets the odour issue in Seaview are the following:

Seaview WWTP Odour control renewal – the aim of this project is to renew the odour control system of the site thus improving the odour treatment performance of the site.

Seaview Sludge Dryer Replacement – the proposed new dryer will have its dedicated odour control system. This will reduce the load to the current odour control system of the site allowing it to have more than enough capacity to treat the odour from other wastewater treatment processes. Having a reliable dryer operation will also lessen the risk of disposing dewatered sludge to the landfill which is also an odour risk.

Odour modelling helps us to understand the performance of odour control system of the site and use it to modify the treatment operation

As Wastewater treatment has a varying degree of odour risk especially if the treatment process fails, the following projects aims to have a more reliable treatment operation which in turn reduce

Milliscreen replacement

Reactive Renewals

Planned Renewals

Screening Wash press replacement Clarifier Renewal

Aeration System Renewal

RAS and WAS System Renewal

Grit Removal

Centrifuge Dewatering Renewal
