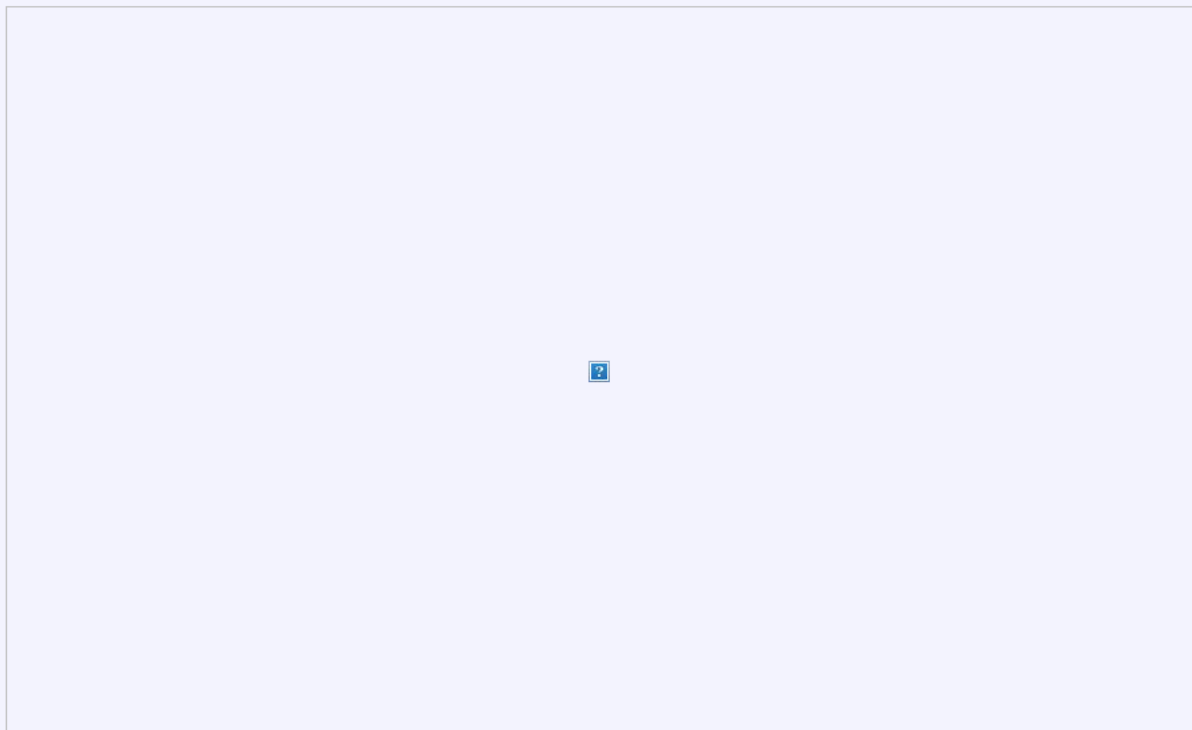
Thank you for your information request asking for information about proposed changes to Purser Grove Park.

The proposed landscape development project came from the Valley Floor review document for the Eastern Suburbs. This document is on the Council's website under 'Strategies'. See

The funding for the project came through the Annual Plan. Purser Grove was chosen for landscaping by Council offers because, apart from the small under 5's playground and the small pathway going from Waiwhetu Road through to Purser Grove, the reserve is underdeveloped. Our officers considered that the reserve would benefit from improvements to create a better amenity for the rapidly growing local demographic.
